INSPECTION PERIOD FOR THE PROPERTY TAX ASSESSMENT ROLL

The Whitley County real property tax roll will be open for inspection from May 29th through June 12th, 2025 under the supervision of the property valuation administrator (PVA) or one of the deputies, any person may inspect the tax roll.

This is the January 1, 2025 assessment on which state, county, and school taxes for 2025 will be due about September 15, 2025.

The tax roll is in the office of the property valuation administrator in the county courthouse and may be inspected between the hours 8:00

Any taxpayer desiring to appeal an assessment on real property made by the PVA must first request a conference with the PVA office. Conferences may be held via videoconference, where available, or by telephone; or you may exchange correspondence requesting a conference with the PVA via email or fax. You will be instructed on the best method of submitting your documentation after contacting our office regarding your request to have a conference. The PVA office is located at: 200 Main St., 2nd Floor Courthouse, Williamsburg, KY.


Any taxpayer still aggrieved by an assessment on real property, after the conference with the PVA or designated deputy, may appeal to the county board of assessment appeals.

Any taxpayer failing to appeal to the county board of assessment appeals, or failing to appear before the board, either in person or by designated representative, will not be eligible to appeal directly to the Kentucky Board of Tax Appeals.
