While prison time may be sought in some cases, Bowling said that the greater motivation is to see compliance with the court's orders and to compel child support payments to caretakers to ensure children are properly provided for.

Bowling said that in all 84 cases, child support had not been paid in at least six months and, in many cases, defendants hadn't paid child support well in excess of six months.

A News Journal review of the indictments show that only three people were indicted, who owed less than \$10,000 in child support. The smallest amount owed was \$2,786.42. while the largest amount owed out of all the defendants was \$221,880.07.

The average arrearage owed is in around \$20,000, Bowling said.

Bowling said that while prosecutors could have indicted hundreds of people, they chose to target the defendants, who owe the largest amount of back child support.

To better improve child support collections, Bowling said that assistant commonwealth's attorney Eric Dixon has been designated as the prosecutor for all flagrant non-support cases.

Bowling noted that Dixon has more than a decade of experience in family court and is well respected in family court. "We have a lot of faith and confidence that he will do a good job to see support is collected," Bowling said.
