**ORDINANCE 032025**  
**AN AMENDED ORDINANCE OF THE CITY OF BEAVER DAM, KENTUCKY**  
**A MUNICIPALITY OF THE FOURTH CLASS,**  
**AMENDING ESTABLISHED FEES, DEPOSITS AND CHARGES**  
**FOR THE USE OF WATER BY RESIDENTS AND NON-RESIDENTS**  
**OF THE CITY OF BEAVER DAM, KENTUCKY**  
Amending Ordinance NO. 021723

The City Commission of the City of Beaver Dam, Kentucky, a municipality of the fourth class, in regular session, do ordains as follows:

WHEREAS, Ordinance no. 021723, the City passed an ordinance which established the procedure, rates, fees and deposits as they relate to the municipal water and sewer service provided by the City of Beaver Dam, Kentucky

WHEREAS, it is now the intent and purpose of the City of Beaver Dam to amend certain portions of the aforementioned ordinance, and

WHEREAS, in order to operate the City of Beaver Dam municipal water service on a sound and economic basis, it is now necessary to increase certain fees, deposits and charges for water service

NOW THEREFORE, the City Commission of the City of Beaver Dam, Kentucky, do ordain as follows:

**50.1Z TAPPING FEE OR CHARGE**

(B) For a connection to the municipal water system inside the corporate limits of the city a charge shall be made to the customer for a 5/8 by 3/4 water meter installation \$1,000.00, one inch meter installation \$1,500.00, a one-and half inch meter installation \$4,200.00 and two inch meter installation \$5,00.00. For all other meter installations, the customer shall pay all the costs incurred by the city, including cost of labor.

(C) For a connection to the municipal water system inside the corporate limits of the city a charge shall be made to the customer for a 5/8 by 3/4 water meter installation \$1,000.00, one inch meter installation \$1,500.00, a one-and half inch meter installation \$4,200.00 and two inch meter installation \$5,00.00. For all other meter installations, the customer shall pay all the costs incurred by the city, including cost of labor. (K0C610.6) (Ord., passed 11-13-78; Am. Ord. 61490-2, passed 6-4-90; Am.
