**ORDINANCE NO 802** AN ORDINANCE RELATING TO STREET-LEGAL SPECIAL PURPOSE VEHICLES WITHIN THE CITY OF OWENTON, KY

NOW, THEREFORE, BE IT ENACTED BY THE CITY OF OWENTON AS FOLLOWS:

WHEREAS, 2025 Ky. Acts Ch. 89 (hereinafter "the Act") became law on March 26, 2025, and allows for the operation of street-legal special purpose vehicles on certain highways within the Commonwealth of Kentucky if allowed by ordinance of the local government within whose jurisdictional boundaries the highway is located, and WHEREAS, the Act becomes effective on Friday, June 27, 2025

and **WHEREAS**, the Owenton City Council has determined that it is appropriate to allow the operation of street-legal special purpose

vehicles on specified highways within the jurisdictional boundaries of Owenton in accordance with the Act and this ordinance. NOW, THEREFORE, BE IT HEREBY ORDAINED by the Owenton City Council: **SECTION 1.** 

**Definitions** 

The definitions set forth in Section 1(1) of the 2025 Ky. Acts Ch. 89 (hereinafter "the Act"), as may be amended in the future by the Kentucky General Assembly, are adopted and incorporated by reference as if set forth fully herein.

Designated Highways

Upon the effective date of the state statues referenced above regarding "Street-Legal Special Purpose Vehicles" a person may operate "Street-Legal Special Purpose Vehicles" on any public oad or highway maintained by and or under the control of the City of Owenton or the Kentucky Department of Highways, sub-

ject to the following requirements and exceptions: 1. The "Street-Legal Special Purpose Vehicle" shall at all times comply in all respects with any and all federal and state statutes and regulations, including but not limited to, all safety requirements as well as registration and insurance requirements The operator of the "Street-Legal Special Purpose Vehicle"

shall at all relevant times be properly licensed to operate a motor vehicle.

3. The "Street-Legal Special Purpose Vehicle" shall not be operated limit exceeds. ated upon any road or highway where the speed limit exceeds

fifty-five (55) miles an hour. 4. The "Street-Legal Special Purpose Vehicle" shall not be operated upon any road or highway where such vehicles are prohibited by federal or state law.
SECTION 3.

This Ordinance shall only apply to the incorporated areas of Owenton, Kentucky,

# SECTION 4.

**Prohibitions** 1. "Street-Legal Special Purpose Vehicles" are prohibited from traveling a distance greater than twenty (20) miles on a highway displaying centerline pavement markings.

Minitrucks shall not be operated as street-legal special purpose vehicles on a highway that has been constructed pursuant to a federal highway program **SECTION 5**.

1. Any person violating any provision of this Ordinance shall be guilty of a violation and punished by a fine not to exceed \$250.00 per violation and shall be subject to penalties as provided by federal or state law. SECTION 6.

# Severability

If a provision of this act or its application to any person or circumstance is held invalid, the invalidity does not affect other provisions or applications of the act that can be given effect without the invalid provision or application, and to this end the provisions of this act are severable. Given first reading in regular session this 14\_ day of August,


