## Woman drowns in Southfork, near Beattyville

The Lee County Coroner's Office reports that at approximately 12:15 a.m. on May 10th, Lee County 911 received a report of a person that had fallen in the South Fork of the Kentucky River near Beattyville.

Although resuscitation

efforts were carried out, they were unsuccessful and the individual was pronounced deceased on scene by the Lee County Coroner's Office.

According to Lee County Deputy Coroner Kenneth Lewis, the person in question has been identified of Kathy Peters, age 70, of Richmond, Kentucky. The cause of death is still under investigation pending autopsy results.

## City honors memory of Joanne Dunaway

The Beattyville City Council met in regular session on Monday, May 12th at 6 p.m. at City Hall. Mayor Scott Jackson, council members Sam Cockerham, Ronnie Stamper, Glenna Cummins, Charlotte Hogan and Mitch Cornelius were in attendance. Council member Savannah Mays was absent.

The first item on the agenda was a Memorial Resolution honoring the Life & Legacy of Joanne Dunaway. Dunaway, a driving force in developing the revitalization of downtown Beattyville, passed away recently. Members of her family were in attendance to accept the Resolution.

Linda Smith informed the Council that the Louisville Orchestra would be presenting a special concert on Happy Top this Saturday, May 17th at 1 p.m. The concert will feature Grammy Awardwinning Music Director Teddy Abrams and acclaimed vocalist La'Shelle Allen. They will do the debut test of their brand-new automated rollout mobile stage which they will be using in their upcoming concert series which will be at Happy Top on September 12, 2025.

Mike with KRADD gave an update on ongoing projects and grant applications.

Charlene Dunaway and Susan Hobbs addressed the Council requesting a grant for Resurrection Homes "Helping Grandmothers" program in the amount of \$15,000. The City Council received \$124,000 from the Opioid Settlement Fund and asked for any group needing money that would fit the criteria to present a proposal to the Council. Resurrection Homes was the only organization that applied. Mitch Cornelius made a motion to grant the organization \$20,000 of the funds.

Ronnie Stamper seconded the motion with all voting aye with the exception of Glenna Cummins who refrained from voting.


Other organizations interested in this grant are ask to contact City Hall.
