n Tuesday, August 19, the Winchester City Commission held its regular 4:30 p.m. meeting.

#### City Commission recognizes Elkins, provides project update

he Winchester City Commission met on Tuesday, August 19. Several items were on the

agenda - including honors and updates to projects.

Among them was one honoring Republican State Senator Greg El-

Elkins, a Clark County native and longtime businessman, won the 28th District seat in the Kentucky Senate during a special election in 2023.

At Tuesday's meeting, he received the Kentucky League of Cities' Friend of Cities Award.

"There's not a better person you could have...representing you all," stated Gracie Kelly, Director of Government Affairs at Kentucky League of Cities. "He is loyal. He's a friend, and [with] every single issue that comes up...if he thinks it impacts local government...he [contacts] me...that is a true gift."

According to the website of the Kentucky General Assembly at Legislator-Profile.aspx, Elkins - who is a member of numerous committees and caucuses - served as a sponsor on numerous bills during both the 2024 and 2025 regular sessions.

Particularly, he was a primary sponsor of bills involving school bus safety and school boards, contracts for the improvement of real estate, motor vehicles and railroad operations, and more.

He has also sponsored various Senate Resolutions, including one honoring George Rogers Clark High School's JROTC for their victory at the 2024 U.S. Army Cadet Junior ROTC Raider Challenge.

J.D. Chaney, CEO and Executive Director, provided some thoughts.

"It's always a good reason to be able to come to a city to honor the legislative work of a legislator," he said. "Our Board of Directors selects a handful of legislators who step up and stand out on legislative issues, especially for local government and city governments...so it's not the easiest award to achieve."

Elkins also responded.

"What Winchester needs isn't necessarily what Paducah needs or what Lexington needs," he said. "It means a lot to me to support our local governments."

In other news, Clark County Circuit Court Clerk Tony Kirk was present and gave an update regarding construction of a new courthouse.
