Floodplain and Wetland Notice of Explanation Activity in a 100-Year Floodplain

To: All interested Agencies all Federal, State, and **Local Groups and Individuals**

This is to give notice that the City of Campton under 24 CFR Part 58 has conducted an evaluation as required by Executive Order 11988 and/or 11990, in accordance with HUD regulations at 24 CFR 55.20 Subpart C Procedures for Making Determinations on Floodplain Management, to determine the potential affect that its project in the floodplain and wetland will have on the human environment for Campton Water Treatment Plant Improvements Project under WX21237018. The proposed project is located in the City of Campton, Wolfe County, Kentucky. The City of Campton will use funding to rehabilitate the existing water treatment plant. Upgrades will include replacing, rehabilitating, and updating the following items: membrane filters, high service pumps, raw water pumps, telemetry, chemical feed systems, metering pumps, filter controls, laboratory equipment/analyzers, various controls, valves, and piping.

The City of Campton has considered the following alternatives and mitigation measures to be taken to minimize adverse impacts and to restore and preserve natural and beneficial values: The City of Campton evaluated alternatives. The first option was to do nothing. This option will result in the lack of sanitary facilities for public use. The second option was to construct a brand-new water treatment facility. This option would be outside of the City's budget and would need to be phased.

Part of the project may be in the 100-year floodplain as designated by the 2022 FEMA Floodplain Maps; with very minimal impacts to the floodplain

The City of Campton has re-evaluated the alternatives to building in the floodplain and has determined that it has no practicable alternative. Environmental files that document compliance with steps 3 through 6 of [Executive Order 11988 and/or 11990], are available for public inspection, review and copying upon request at the times and location delineated in the last paragraph of this notice for receipt of comments. This activity will have no significant impact on the environment for the following reasons:

There will be minimum tree and vegetation removal. This project will provide better service to residents within the City of Campton service area, as well as continue improvement of the overall system. Once completed the project will not impede the floodplain. This is the most economical and least environmentally impacting alternative considered.
