## Completion date announced for Livingston Creek bridge

LYON COUNTY, Ky. - In March of 2024, there was an abrupt closure of the Livingston Creek Bridge at KY-295 between Crittenden and Lyon County.

At the time, the bridge was closed and blocked off for commuters until further notice. This was due to an inspection team discovering deteriorated beams and serious structural issues of the old bridge, according to KYTC District 1.

An important rural route for those traveling between Dycusburg and Eddyville/Kuttawa and with less-than-ideal detours, both residents, city and county leaders voiced their concerns, hoping for answers and a potential time for con-

struction of a new bridge. In November of 2024, Lyon County Judge Jaime Green-Smith said that she had reached out to KYTC District 1, hoping to have it reopened with tonnage limits so some could continue using it. Others hoped that the old bridge could simply be repaired. Though no official answers were given, both options were assumed to be too hazardous to partially open, or that repairing the bridge might be too costly than building anew.

Demolition of the former Livingston Creek Bridge officially began on May 2, 2025, signaling quick progress. In the following months, the new bridge has been moving steadily along, and now, there is an official completion date.

According to Carrie Dilliard, Public Information Officer with KYTC District 1, Dilliard told the Herald Ledger that construction crews are currently setting up beams and putting down deck pans. The new bridge will be a single-span bridge with concrete beams, whereas the previous bridge was a five-span with steel I-beams. Jim Smith Contracting is also the primary contractor on this \$1.236 million bridge replacement project.
