Nicholas County Judge Executive, Steve Hamilton is pleased to announce that the Nicholas County Fiscal Court has been awarded funding in the amount of \$570,000.00, through House Bill 546 to resurface Locust Grove Road.

It has been a very rigorous process as the court was denied funding in the 2024 budget, and had to reapply for year

2025, and received word on March 28, 2025 that they had been awarded. Monies will not be available until July 1, 2025, in the state's new budget.

Plans are to bid out the project this summer and start paving in the fall. The fiscal court appreciates the joint effort locally and at the state level, without everyone coming together it would not have been possible.


