"I heard it's turning the cows blue," my grandfather said from the driver's seat in a tone more serious than he had used all day. My older sister replied from the passenger side, "Showed up in San Francisco I've heard. Trees, chickens, horses... nothing's immune." They'd been going back and forth for almost the entire 20-minute drive to my grandfather's farm, and I was getting worried. I didn't catch all of the details, but I heard the worst of it. A paranormal phenomenon had swept across the country: The Blue Mist.

The old countryside nestled in the north part of Kentucky usually brought comfort, but

with every advancing crick and curve in the road, I dreaded our arrival even more. Before I knew it, the car was parked in front of the gate, and my little hands were shaking as they unlatched it. It couldn't be true, could it?

I got back in the car, my heart pounding in my chest, convinced that every cattle farmer from there down to Georgia could hear it. The gear of the rusted red minivan shifted into drive, and the end of the long gravel driveway came quicker than it ever had. As we approached the old tobacco barn, my sister looked to her right, down the hill, and toward the ponds. "Look!" she exclaimed, and we did.
