Paris man arrested in Nicholas County leads to felony charge in Bourbon County

Paul Feeback, 29, of East 19th Street, Paris, Ky., was arrested on Friday, April 25, 2025, by Carlisle Police Officer Josh Mynear, and has been charged with one count of Driving DUI Suspended License – 2nd Offence (Aggravating Circumstances); one count of Operating a Motor Vehicle Under the Influence of Alcohol .08 - 2nd; and one count of Failure to Produce Insurance Card.

Mr. Feeback's arrest in Nicholas County led to a further charge in Bourbon County, where he was charged with one count of Theft by Unlawful Taking or Disposition – Auto $(\$\bar{1},000 < \$\bar{1}0,000).$

According to the Uniform Citation from the Carlisle Police Department, on April 25, 2025, at 1:01am, Officer Mynear was dispatched to the area of North Broadway Street and Green Valley Road, in reference to a reported reckless driver.

Upon reaching the area, Officer Mynear began attempting to locate the vehicle in question and began driving down nearby streets when he made contact with a white Ford F150 located on West North Street, and initiated a traffic stop on the vehicle. Officer Mynear then made contact with a male driver identified as Paul Feeback, who stated he "had a flat tire" as he was driving on the rim with the rear driver tire shredded. Officer Mynear then observed extensive damage to the driver's side of the vehicle, starting from the front fender extending

to the rear fender. Officer Mynear then asked Mr. Feeback if he was involved in a accident and he stated he "had not hit anything" and during

this time he displayed slurred speech, as well as having red glassy eyes. The officer then asked Mr. Feeback if he had been drinking any alcoholic beverages and he stated, "Yes I have." The officer then asked what kind, and Mr. Feeback stated, "Kentucky Ale whiskey." The officer then asked Mr. Feeback how much he had drank and he stated, "a pint."

At that time Officer Mvnear asked Mr. Feeback to perform SFST's (Standard Field Sobriety Tests) and he agreed. Mr. Feeback refused to perform the one-leg stand and stated, "I'm guilty, just take me to jail." He was then placed under arrest and Officer Mynear took photos of the damaged vehicle before having it towed from the roadway. At that time, it was unknown what caused the damage to the vehicle, and Mr. Feeback was unable to provide proof of insurance for the vehicle at the time of his arrest.

Mr. Feeback was transported to the Carlisle Police Department where Officer Mynear conducted a started intoxilyzer test, resulting in 0.245. was then transported to the Bourbon County Detention Center on a \$3,500.00/10% bond for the charges in Nicholas County and eventually no bond for the charge in Bourbon County.

Regarding the charge in Bourbon County, according to the Millersburg Police Department Facebook

page, on April 25, 2025, at approximately 7:21 p.m., Chief Ben Smith was dispatched to speak to a Millersburg resident regarding their vehicle being stolen. While speaking to the victim, Chief Smith learned that at approximately 1:01 a.m., Carlisle PD located the victim's vehicle being operated in Carlisle by Paul Feeback of Paris, KY.

The vehicle had severe damage consistent with being involved in a collision; however, it was unknown how the damage occurred. The victim advises that the vehicle will likely be deemed a total loss. Mr. Feeback was ultimately arrested by Carlisle Police Department for DUI-related offenses and lodged in the Bourbon County Detention Center. The victim's vehicle was

During Chief Smith's investigation, it was discovered that the victim and Mr. Feeback are close acquaintances, and Mr. Feeback was temporarily residing in a property owned by the victim at the time of the theft. It was determined that unbeknownst to the victim and without permission, Feeback stole the vehicle during the evening hours of April 24th. As a result of the Millersburg Police Department investigation, Mr. Feeback was charged with Theft by Unlawful Taking (Automobile) \$1,000 < \$10,000.

Paul Feeback is scheduled for arraignment in Nicholas County District Court for the DUI charges on April 30, 2025, at 10:30am, and scheduled for arraignment in Bourbon County District Court for the theft charge on April 30, 2025, at 1:00pm.

All persons are to be presumed innocent until proven guilty or pleading guilty.

Millersburg man arrested for possession of heroin

John Talbot Manley, 42, of Main Street, Millersburg, Ky., was arrested on Wednesday, April 23, 2025, by Carlisle Police Officer James Copher, Jr., and has been charged with one count of Possession of a Controlled Substance -1st Degree, 1st Offense (Heroin).

According to the Uniform Citation, Officer Copher, Jr. received a call to the alley beside the old Farm Bureau Building on Main Street in Carlisle, Ky., in reference to Mr. Manley passed out inside of his car. When Officer Copher, Jr. arrived, Mr. Manley was slumped over the wheel. The officer got Mr. Manley to wake up and talk to him, and he asked Mr. Manley to step out of the vehicle. Officer Copher, Jr.

asked Mr. Manley if he had anything on him or if he had used any drugs. Mr. Manley stated that he did not, and that the officer could search him. While searching, Officer Copher, Jr. found a small red glass container with a black metal top. Mr. Manley stated that it was drugs. After opening it, there was a gray powder substance inside that looked to be gray heroin. John Talbot Manley subsequently ar-

Edgar Carson, 43, of West North Street, Carlisle, Ky., was arrested on Thursday, April 17, 2025, by Carlisle Police Officer James Copher, Jr., and charged with one count of Trafficking in a Controlled Substance -1st Degree, 1st Offense, - (> or = 2 grams Methamphetamine).

According to the Uniform Citation, on April 2, 2025, Carlisle Police Officers Scott Johnson and James Copher, Jr. executed a search warrant on Edgar Carson's blue

Chevrolet truck. The truck was towed a few days prior, due to driving on suspended and a warrant, when Mr. Carson came to the courthouse. When the officers towed the truck, it was stored in Hughes' Towing garage, where the garage was locked, until Officer Copher, Jr. could execute

Once the officers did the search warrant, they found approximately 3 grams of methamphetamine, several 2x3 ziplock style baggies, a small spoon, a scale, and

\$35.00 in cash. Edgar Carson was subsequently arrested and lodged in the Bourbon County Detention Center on a \$5,000.00 cash bond. He is scheduled for a preliminary hearing in Nicholas County Circuit Court on Wednesday, April 30, 2025, at

10:34am. All persons are presumed innocent until proven guilty or pleading guilty.

2025 INSPECTION PERIOD FOR THE ROBERTSON COUNTY PROPERTY TAX ASSESSMENT ROLL

The Robertson County real property tax roll will be open for inspection from May 5th through May 19th, 2025. Under the supervision of the property valuation administrator (PVA) or one of the deputies, any person may inspect the tax roll.

This is January 1, 2025, assessment on which state, county, and school taxes for 2025 will be due about October 1, 2025. The tax roll is in the office of the property valuation administrator in the county courthouse and may be inspected between

the hours of 9am-4pm Monday, Tuesday, Thursday and Friday; 9am-noon on Wednesday and 9am-noon on Saturday.

Any taxpayer desiring to appeal an assessment on real property made by the PVA must first request a conference with the PVA or a designated deputy. The conference may be held prior to or during the inspection period. Conferences may be in person, may be held by telephone; or you may exchange correspondence requesting a conference with the PVA via email or fax. Written documentation supporting your opinion of value will continue to be required no matter what the method. You will be instructed on the best method of submitting your documentation after contacting our office regarding your request to have a conference.

Any taxpayer still aggrieved by an assessment on real property, after the conference with the PVA or designated deputy, may appeal to the county board of assessment appeals.

The appeal must be filed with the county clerk's office no later than one workday following the conclusion of the inspection period. Please contact the county clerk's office to receive instructions on the method the office is using to accept appeals this year and to obtain a form that can be used to file your appeal. Any taxpayer failing to appeal to the county board of assessment appeals, or failing to appear before the board, either in

person or by designated representative, will not be eligible to appeal directly to the Kentucky Board of Tax Appeals.

Appeals of personal property assessments shall not be made to the county board of assessment appeals. Personal property taxpayers shall be served notice under the provisions of KRS 132.450(4) and shall have the protest and appeal rights granted under the provisions of KRS 131.110.

The following steps should be taken when a taxpayer does not agree with the assessed value of personal property as determined by the property valuation administrator.

- (1) He must list under protest (for certification) what he believes to be the fair cash value of his property. (2) He must file a written protest directly with the Department of Revenue, Office of Property Valuation within 30 days from the date of the notice of assessment.
- (3) This protest must be in accordance with KRS 131.110.
- (4) The final decision of the Department of Revenue may be appealed to the Kentucky Board of Tax Appeals.

2025 INSPECTION PERIOD

FOR THE PROPERTY TAX ASSESSMENT ROLL

The Nicholas County real property tax roll will be open for inspection from May 5 through May 19, 2025. Under the supervision of the Property Valuation Administrator (PVA) or a deputy, any person may inspect the tax roll.

This is the January 1, 2025 assessment on which state, county, and local district's taxes for 2025 will be due about October 1, 2025.

Any taxpayer desiring to appeal an assessment on real property made by the PVA must first request a conference with the PVA or designated deputy. The conference can be held in person at our office or by phone at 859-289-3735, prior to or during the inspection period. Documentation supporting your opinion of value will be required, i.e. a recent property appraisal, recent comparable sales, or insurance policies. Our office hours are Monday through Friday, 8:30 to 4:30. If these times are inconvenient, please call and we can schedule an appointment that is convenient for you. The office is located in the basement of the Nicholas County Courthouse.

Any taxpayer still aggrieved by an assessment of real property, after the conference with the PVA or designated deputy, may appeal to the County Board of Assessment Appeals.

The appeal must be filed with the Nicholas County Clerk's office no later than one work day following the conclusion of the inspection period on May 19, 2025, stating the reasons for appeal, identifying the property, and stating the taxpayer's opinion of the fair cash value of the property. Please contact the county clerk's office to receive instructions on how to file your appeal.

Any taxpayer failing to appeal to the county board of assessment appeals, or failing to appear before the board, either in person or by designated representa-

tive, will not be eligible to appeal directly to the Kentucky Board of Tax Appeals.

Appeals of personal property assessments shall not be made to the county board of assessment appeals. Personal property taxpayers shall be served notice under the provisions of KRS 132.450(4) and shall have the protest and appeal rights granted under the provisions of KRS 131.110.

The following steps should be taken when a taxpayer does not agree with the assessed value of personal property:

- (1) Taxpayer must list under protest (for certification) what he believes to be the fair cash value of his property.
- (2) Taxpayer must file a written protest directly with the Department of Revenue, Office of Property Valuation within 30 days from the date of the notice of assessment.
- (3) This protest must be in accordance with KRS 131.110.
- (4) The final decision of the Department of Revenue may be appealed to the Kentucky Board of Tax Appeals
