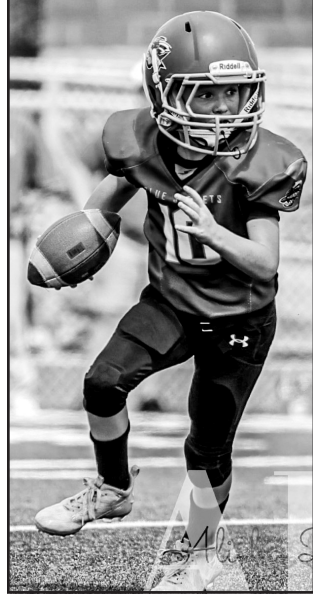
The Hype Sports Media Impact Player of the Games were Bluejacket Parker Reid – 6th grade and Bluejacket EJ Rhodes – 5th grade.

NCMS Bluejackets take down Sayre

The Nicholas County Middle School Bluejackets football team hosted Sayre (Lexington, Ky.) on Thursday, Aug. 21, 2025, at NCMHS, for their final scrimmage game before the regular season begins.

During the end of the first quarter the Jackets were set to score, but a red zone fumble was recovered by Sayre, with no score on the board at the end of the first quarter.

The Jackets put 8 on the board with a second quarter touchdown and extra point by Ty Simons, going into the half, with Nicholas County up 8 on Sayre's 0.

A crazy third quarter saw Sayre fumble with Nicholas recovering, and then a Nicholas fumble with Sayre recovering for a touchdown, putting 6 on the board, with a 2-point conversion coming up as no good.

Going into the 4th quarter, the score was 8-6 with the Jackets leading, and soon af-

ter another 8 points put on the board by Nicholas County, thanks to a touchdown from Bentley Scott, and the extra point by Ty Simons, with a final score of Bluejackets 16 – Sayre 6.

Following the game, Coach Sam Reid posted on the NCMS Football Facebook page... “Nice win by the Bluejackets tonight against a good Sayre team, 16-6!! The boys controlled the time of possession and did well defensively! We left a lot of points out there and have much to improve on next week, as this could have been a much different game if we were more disciplined in certain areas. Still proud of the effort tonight! We didn't give up, we didn't quit, we kept playing until the end. Keep playing hard and keep working hard, boys! TOGETHER we will achieve more!”

The NCMS Bluejackets next two games are on the road, on Aug. 28th against West Carter and on Sept. 4th against Mason County. Their next home game is scheduled for Sept. 11th against Rowan County.
