A Benefit auction held in support for Johnathan and Petrea Allison was held on Saturday evening, Aug. 23, 2025, at The Center Venue (formerly Vice's Community Center), located on Moorefield Road, and drew a very large crowd, in support for Mr. and Mrs. Allison.

The benefit, which was from 6:00 to 9:00pm, consisted of a meal, including hamburgers, hot dogs, baked beans, cole slaw, chips, and drink for \$10.00, desserts for \$2.00, a Split the Pot, a door prize, and an auction (organized by Eddie Purcell), with all proceeds going to Johnathan and Petrea.

The winner of the Split the Pot was Rhonda Markland, with a grand total of \$310.00, she won \$155.00, which she donated back to Johnathan and Petrea. The winner of the door prize was Anna Carter, who won a Kindle.

Johnathan has been in the hospital for over 8 weeks, and Petrea has been there with him every

second. Johnathan had gallbladder surgery, along with pancreatitis and fluid build-up, and is currently recovering in the University of Louisville Hospital but still has a long recovery process to go.

The benefit was to help Mr. and Mrs. Allison with medical bills, meals, and gas when they finally get to leave the hospital.

ORDINANCE 2025-4

AN ORDINANCE LEVYING CITY OF CARLISLE TAXES FOR GENERAL MUNICIPAL PURPOSES FOR THE FISCAL YEAR OF 2025/2026 ON PERSONAL PROPERTY, OTHER THAN MOTOR VEHICLES AND WATERCRAFT, WITHIN THE TAXING JURISDICTION OF THE CITY OF CARLISLE SHALL BE AT THE RATE OF \$0.42 PER ONE HUNDRED (\$100.00) DOLLARS OF ASSESSED VALUATION.

Be it ordained by the City of Carlisle:

Section 1. That for the purpose of general support of the government of the City of Carlisle, and the payment of its debts and expenses for the fiscal year of 2025/2026, there be and hereby are levied ad valorem taxes on each one hundred (\$100.00) dollars of the January 1, 2025 assessed valuation by the Nicholas County Property Valuation Administrator of all personal property, other than motor vehicles and watercraft within the taxing jurisdiction of the City of Carlisle shall be at the rate of \$0.42.

Section 2. This Ordinance shall take effect upon its passage and publication in full as required by law.

AN ORDINANCE LEVYING CITY OF CARLISLE AD VALOREM TAXES FOR GENERAL MUNICIPAL PURPOSES FOR THE FISCAL YEAR OF 2025/2026 ON REAL ESTATE WITHIN THE TAXING JURISDICTION OF THE CITY OF CARLISLE AT THE RATE OF \$0.2475 PER ONE HUNDRED (\$100.00) DOLLARS OF ASSESSED VALUATION.

Be it ordained by the City of Carlisle:

Section 1. . That for the purpose of general support of the government of the City of Carlisle, and the payment of its debts and expenses for the fiscal year of 2025/2026, there be and hereby are levied ad valorem taxes on each one hundred (\$100.00) dollars of the January 1, 2025 assessed valuation by the Nicholas County Property Valuation Administrator of all real estate within the taxing jurisdiction of the City of Carlisle, at the rate of \$0.2475 cents.

Section 2. This Ordinance shall take effect upon its passage and publication in full as required by law.

CITY OF CARLISLE
ORDINANCE 2025-2

AN ORDINANCE LEVYING CITY OF CARLISLE AD VALOREM TAXES FOR GENERAL MUNICIPAL PURPOSES FOR THE CALENDAR YEAR OF 2025 ON MOTOR VEHICLES AND WATERCRAFT WITHIN THE TAXING JURISDICTION OF THE CITY OF CARLISLE SHALL BE AT THE RATE OF \$0.66 PER ONE HUNDRED (\$100.00) DOLLARS OF ASSESSED VALUATION.

Be it ordained by the City of Carlisle:

Section 1. That for the purpose of general support of the government of the City of Carlisle, and the payment of its debts and expenses for the calendar year of 2025, there be and hereby are levied ad valorem taxes on each one hundred (\$100.00) dollars of the January 1, 2025 assessed valuation by the Nicholas County Property Valuation Administrator of all personal property, other than motor vehicles and watercraft within the taxing jurisdiction of the City of Carlisle shall be at the rate of \$0.66.

Section 2. This Ordinance shall take effect upon its passage and publication in full as required by law.
