Notice is hereby given that Columbia Gas Transmission, LLC (700 Louisiana St. Houston, TX 77002), has filed an application with the Energy and Environment Cabinet to construct the NKY Gate Enhancement Project which is located in Mason, Nicholas, Bracken, Pendleton, and Campbell Counties, Kentucky, and Hamilton County, Ohio, and involves various natural gas pipeline replacements, pipeline abandonments, and installation of new natural gas pipelines in addition to the installation of new points of delivery and modifications to existing points of delivery. The proposed Project crosses Jimmie Creek, Four Mile Creek, Twelvemile Creek, Tug Creek, Owl Creek, Somerset Creek, Stepstone Creek, Flag Spring Creek, Duck Creek, Brush Creek, the Ohio River, and unnamed tributaries.
