Text Scammers Posing as State Agency

Guidance offered by agency on how to avoid disclosing sensitive information

The Kentucky Transportation Cabinet (KYTC) is warning Kentuckians of continued reports of fraudulent text messages sent out, impersonating their agency. These messages contain links that look similar to Kentucky government website addresses.

The scam messages

recommendations below to avoid disclosing sensitive information to scammers.

Tips to Spot a Scam Text

KYTC does not collect traffic ticket fees or notify customers of violations using text messages.

Government websites

driver services is drive. ky.gov. Websites that mimic that address are likely a scam.

Be aware that what you see on a text or email could say the correct thing, but that doesn't mean you will go to the right place when you click on them. When someone inserts a link in a text

suspicious message to 7726 (SPAM) to alert your mobile provider.

If you aren't sure it is a scam, look up the agency in the phone book or call directory assistance (411) and then call the agency directly. Never use the phone number that comes in any text or email that you have even the slightest reason to suspect.

If You Were Fooled

Anyone who may have provided any personal information to criminals should contact their bank immediately and tell them everything.

Your banker can help you cancel any cards, credit or debit, you may have given criminals access to.

They can also: advise you on how to monitor your credit going forward; ensure your retirement and other accounts aren't emptied; lock down your credit, so your home is less likely to be sold or mortgaged by someone; prevent others from taking out new loans in your name; generally take the steps you can to try to ensure that your identity will not be used by others.

Seeking Retribution

The agencies

Local law enforcement doesn't have the manpower, equipment or training to pursue these criminals. That includes the local police in Louisville, Atlanta and so on.

Texts are for

communicating with family and friends. You can be notified of weather, missing persons and other such things via text if you sign up for those services. Police, the courts, and other such agencies do not use text messages to collect fines, fees, threaten you with jail or "Loss of Driving Privileges."


Lucinda Cemetery

The agency reports they are taking steps to have the fraudulent websites taken down. Kentuckians are encouraged to follow the tips and

end in .gov, but never .com, .net, or anything else.

The only 'KDOT' is a radio station in Nevada. Kansas' agency is KSDOT. Kentucky, being a commonwealth, has cabinet agencies and doesn't have a 'DMV.' Any messages using those terms are a scam.
