If forwarded by mail, the sealed envelope containing the bid must be enclosed in another envelope and mail to the above address. Mailed bids must reach this physical address prior to the scheduled closing time for receipt of proposals.

The OWNER reserves the right to waive formalities or to reject any or all bids. Each BIDDER must deposit with his bid, security in the amount, form and subject to the conditions provided in the Instructions to Bidders.

Award of the Contract shall be made to the lowest, responsive responsible bidder. Refer to the Contract Specifications for specific requirements.

MINORITY FIRMS ARE ESPECIALLY ENCOURAGED TO BID. City of Greenup has established a local labor use goal, refer to section 00715 – Local Labor Goal.

Bids shall be accompanied by a certified check of bid bond payable to the Owner an amount no less than five percent (5%) of the base bid. No bidder may withdraw his bid for a period of ninety (90) days after the date bids are opened. He may, however, withdraw his bid at any time prior to the time and date scheduled for opening of same or any authorized postponement thereof. Any bid received after the time and date specified will not be considered and will be returned unopened to the bidder.

Bidders must comply with the President’s Executive Order Nos. 11246 and 11375, which prohibit discrimination in employment regarding race, creed, color, sex or national origin. Bidders must comply with Title VI of the Civil Rights Act of 1964, the Anti-Kickback Act, and the Contract Work Hours Standard Act.
