ORDINANCE NO. 392-2025

AN ORDINANCE AMENDING ORDINANCE NO 384-2024 OF THE CITY OF SOUTH SHORE, KENTUCKY ESTABLISHING WATER RATES AND TAP FEES, AND AN ORDINANCE SETTING CURRENT RATES AND ADOPTING THE CON-SUMER PRICE INDEX IN RELATION TO FUTURE RATES AND OTHER MATTERS.

WHEREAS, the City of South Shore, Kentucky, desires to increase its water rates and tap fees charged to the customers of the City of South Shore Water Department;

WHEREAS, the City of South Shore desires to base all future rate increases on the

Consumer Price Index.

NOW, THEREFORE, BE IT ORDAINED by the Commission of the City of the South Shore, Kentucky, as follows:

SECTION 1: RATES

The charges for water sold by the City of South Shore shall be as follows:

Any size tap that is not set forth above shall be charged at a rate which will fully reimburse the City for all costs paid by the City for the tap including, but not limited to, the tap itself, labor, fuel, equipment and depreciation. Water taps shall be installed in the road right-of-way unless otherwise authorized in writing by the mayor. Taps not installed in the right-of-way shall be installed with the minimum distance from the main line to the tap. The City reserves the right to refuse to provide service to any location where the cost of providing service is excessive. All users desiring service with the City

of South Shore shall sign a water user contract before water is provided. **SECTION 3**: EFFECTIVE DATE

Said water rate and tap fee changes shall be effective July I, 2025. **SECTION 4: ANNUAL RATE CHANGE SET BY CPI**

I. The City of South Shore shall calculate and implement the increase of any and all future water rates for the usage of water for all City of South Shore customers (both inside the city and outside the city) by applying the percentage of increase of the Consumer Price Index for the preceding calendar year to each current water rate and charge. Said Consumer Price Index shall be that as maintained and reported by the United States Department of Labor and as reported to all local governments by the Kentucky Department of Local Government in February of each year for the preceding calendar vear.

2. The percentage of increase or decrease as set forth in the letter from the Department of Local Government shall be applied to the above rate table, to develop the new rates to be used. The initial implementation of the automatic rate increase is reflected by the above rate changes and shall become effective on or about July I, 2025.

3. For all future years the increase or decrease shall be effective and be used with billings as of July I st for each subsequent year. Notice of the Consumer Price Index percentage increase of each water rate and charge shall be mailed to each customer no later than May 30th or published in a local newspaper qualifying under KRS Chapter 4. The increased rate changes shall take effect in the monthly billing cycle and shall remain in effect for a twelve (12) month period until the new CPL increase in the water

remain in effect for a twelve (12) month period until the new CPI increase in the water rate charges take effect for the following year. If under any circumstances the CPI has not increased in the preceding calendar year, or in the event the increase is less than

I%, the rate will be adjusted at I%.
SECTION 5: RETENTION OF ALL OTHER PARTS OF ORD. NO. 342-2017 That any and all remaining parts, including penalties and interest, of Ordinance No. 342-2017 not directly changed by this Ordinance are hereby adopted and incorporated

herein by reference and/or remain unchanged and affected by this Ordinance.
