ORDINANCE NO. 2025-08

AN ORDINANCE AMENDING ORDINANCE NO. 2023-08
AS TO VEHICLE IMPOUNDING BY THE CITY

WHEREAS, the City of Raceland must periodically impound vehicles in the City; WHEREAS, the City of Raceland believes it will benefit from maintaining an impound lot and the revenue generated from it.

WHEREAS, in order to comply with the Kentucky Revised Statutes and Kentucky Administrative Regulations, the City of Raceland will have to amend Ordinance No

(A) Each section is enacted separately and will continue in force even if another section is declared unconstitutional. That all conflicting ordinances are specifically re-

pealed to the extent of said conflict only.

(B) This Ordinance will become effective and enforceable upon its passage, ap-

proval, and publication as required by law.

(C) The City Clerk of the City of Raceland will be directed to transmit a copy of this Ordinance and any amendments following it, as may be required by law.

(A) This ordinance will amend certain portions of Ordinance No. 2018-2 as specified herein. The amendments of Ordinance No. 2018-2 are done only to the extent of

(B) The City will charge a towing fee of two hundred and fifty dollars (\$250.00) for vehicles involved in a collision, and two hundred dollars (\$200.00) for abandoned

vehicles involved in a collision, and two nundred dollars (\$200.00) for abandoned vehicles and those vehicles impounded as the result of an arrest in violation of KRS 189A.010 or any other vehicles impounded for any reason. This will amend Section 2 of Ordinance No. 2018-2 as to the base towing fee.

(1) For vehicles involved in a collision the City will also charge an EPA fluid and containment fee of one hundred and fifty dollars (\$150.00).

(C) There will be an administrative fee charged by the City in the amount of seventy-five dollars (\$75.00). The proceeds from this fee will go to the police fund for the Raceland City Police Department. This will amend Section 4 of Ordinance No. 2018-2 as to the administrative fee.

(D) The impound fee of Ordinance No. 2018-2 will be increased to sixty-five dollars (\$65.00) per day. This will amend Section 4 of Ordinance No. 2018-2 as to the base

(A) The City will act in compliance with KRS 82.630 and any other applicable

statutes or regulations, in the operation of the impound lot, and the impounding of

(B) Vehicles may only be picked up during normal business hours, Monday through Friday from 8:00AM to 4:00PM.

ORDINANCE NO. 2025-09

AN AMENDMENT TO ORDINANCE NO. 2019-06 IN REGARD TO ADOPTING THE "INTERNATIONAL PROPERTY MAINTENANCE CODE" FOR USE AND ENFORCE-MENT WITHIN THE CITY LIMITS OF RACELAND, KENTUCKY.

WHEREAS, the City of Raceland, Kentucky has determined that it is in the best interest of the City to adopt the International Property Maintenance Code, as presently published and in effect, to serve as the property maintenance standards for the City on a continuing basis; and

WHEREAS, the adoption of said Code will promote the health, safety, and welfare of the residents of Raceland, Kentucky.

THEREFORE, BE IT ORDAINED AS FOLLOWS, Section 1 - General Provisions

(A) Each section of this Ordinance is enacted separately and will continue in force even if another section is declared unconstitutional. All conflicting ordinances are hereby repealed to the extent of such conflict only.

This Ordinance will become effective and enforceable upon its passage, approval, and publication as required by law.

Ordinance, together with the Code adopted herein, and any future amendments to this

(C) The City Clerk of the City of Raceland is directed to transmit a copy of this

Ordinance, as may be required by law. Section 2 - Purpose & Effect The City of Raceland does hereby adopt the International Property Maintenance Code, in its current form as of the date of this Ordinance, and the same is hereby declared to be and will remain the official property maintenance code and rules of the

City of Raceland until such time as it may be amended or repealed by ordinance of the

Section 3 - Enforcement (A) Enforcement of this Ordinance will be under the authority of the City of Raceland Code Enforcement Officer, Police Department, or other authorized official as designated by the City Council.

(B) Each violation of the Code will be, on first offense, considered a violation punishable by a fine of one hundred dollars (\$100.00) and court costs. (C) Each separate day the violation continues after due notice has been served

will be deemed a separate offense.

(D) Any further citations against the same owner of the same property for the same violation will be considered a Class B misdemeanor, punishable by up to ninety (90) days in jail and a fine of up to two hundred fifty dollars (\$250.00), with each day the property remains in violation considered to be a separate offense, together with court costs. Section 4 - Compliance

The City will act in compliance with all applicable provisions of the Kentucky Revised Statutes, including but not limited to KRS Chapter 82 and KRS Chapter 83A, in enforcing the International Property Maintenance Code.
