COUNCIL from Front Page

The Telemetry Improvement Project is currently being advertised for bid. Bids will be received at Booneville City Hall until 3:00 p.m. Wednesday, March 11, 2026. Water Line Replacement Phase 3 is a project replacing aging line in the Hwy 30 East/Lerose area. The project is currently in the design phase. Other projects in progress include the Sewer Force Main Redirect Project, Saul Waterline Project, and multiple FEMA projects. The City is also seeking funding for the Water Plant Rehab Project and Brewer Road Water Line,

among others. Nesbitt Engineering FEMA consultant Jon Allen advised that Clerk Shouse and himself had submitted paperwork to close out three FEMA projects. Superintendent David Hall requested the Commission consider hiring a full-time person dedicated to leak detection, citing approximately 249 miles of water main line and an estimated 220 miles of service line. In conjunction with Telemetry improvements, this position would help utilize system data more effectively. Superintendent David Hall advised that he was very pleased with the crew for going above and beyond during this event. He added that the system is

not out of the woods yet, and with thawing temperatures, additional leaks are likely on mains, service lines, and customer service lines. Commissioner Bobrowski thanked David, the maintenance crew, and all staff for their hard work. Ruth Hensley gave the gross monthly collections report, Clerk Shouse presented financials, and Chief Hudson gave a verbal report to the Commission. The Commission advised staff to evaluate city streets and report any streets needing repair or blacktopping. With no further business, Commissioner Bobrowski moved to adjourn the meeting. Warmer weather is in the forecast.
