### NOTICE OF BLASTING SCHEDULE

PERMIT NO. 895-0175

In accordance with the provisions of 405 KAR 16:120, Sturgeon Mining Company, Inc., PO Box 368, Beattyville, Kentucky 41311, phone (606) 464-8954, proposes the following blasting schedule. The blasting site consists of approximately 274.52 acres located in Owsley and Breathitt Counties approximately 1 mile east of Lucky Fork and 2 miles east of the intersection of Lucky Fork Road and Laurel Fork Road. Detonations of explosives are proposed to occur from sunrise to sunset Sunday thru Saturday. The blasting schedule is for the period from February 1, 2026 to February 1, 2027. Entry to the blasting area will be regulated by signs and barriers. An authorized company representative will prohibit access to the blasting area by unauthorized persons at least 10 minutes prior to each detonation. The warning and all clear signals will be sounded using a siren. The warning signal shall consist of a one minute series of long blasts 5 minutes prior to the blast, the blast signal will be a series of short blasts one minute prior to the shot. The all-clear signal will be a prolonged blast following the inspection of the blast area.
