AN ORDINANCE ESTABLISHING A JOINT PLANNING UNIT PURSUANT TO CHAPTER 100, KENTUCKY REVISED STATUTES

NOW WHEREAS, the City of Mount Olivet submitted interrogatories to the Robertson County Fiscal Court inquiring if Robertson County desired to form and operate a Joint Planning Commission with the City of Mount Olivet, same being dated November 21st, 2025, and

WHEREAS, the Robertson County Fiscal Court approved the formation and operation of a Joint Planning Commission on November 21st, 2025, which Commission is to be called the Robertson County Municipal Planning Commission, and further approved the Agreement to Form and Operate a Planning Unit pursuant to Chapter 100, Kentucky Revised Statutes, all pursuant to the attached document which is incorporated herein by reference as if fully set forth herein, and

WHEREAS, the City of Mount Olivet hereby wishes to similarly approve the formation and operation of the Robertson County Municipal Planning Unit, and approve the attached Agreement to Form and Operate a Planning Unit pursuant to Chapter 100, Kentucky Revised Statutes, and affirm and ratify the Mayor of Mount Olivet's signature on the attached Agreement to Form and Operate a Planning Unit pursuant to Chapter 100, Kentucky Revised Statutes.

NOW THEREFORE, BE IT ORDAINED BY THE CITY OF MOUNT OLIVET, KENTUCKY as follows:
